A RESOLUTION OF THE BOARD OF TRUSTEES TOWN OF BAYFIELD, COLORADO,

Business License Fees

WHEREAS, the Board of Trustees adopted Ordinance 447 Business License Section 5-23 Registration fees. "The board of trustees shall, by resolution, establish appropriate fees for the original license and any renewals and from time to time change such fees."; and

WHEREAS, a fee schedule has been determined and established with this Resolution.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF BAYFIELD, COLORADO AS FOLLOWS:

With exception to fees adopted by Ordinance the following is the annual fee schedule January 1 to December 31 for Business License application and renewal.

\$30	Itinerant First 6- months	Section 5-19 (3)	<u>Itinerant Business</u> means any business conducted in a building, tent, from a truck, van or trailer, on a parking lot or vacant parcel
\$45	Itinerant Remaining months in the year	Section 5-19 (3)	of land, or a sanctioned Town event with property owner permission, for a temporary period of time. Includes, food truck/trailer, parking lot sales, garage/yards. Under one business license, the business operation has the option to designate no more than three temporary locations.
\$150	Market Coordinator	Section 5-19 (4)	<u>Market Coordinator</u> means one individual or organization (including a non-profit) that organizes a market. Cottage Food Act eligible participants participate at market coordinator invitation.
\$25	Street Vendor/Booth	Section 5-19 (5)	<u>Street Vendor/Booth Business</u> Cottage Food eligible participants that are not represented by a Market Coordinator, retail sales, product display, political, informational pamphlets, fee based mini carnival type activities and other organizations that are associated with a Special Event activities.
\$30	Delinquent Fee	Section 5-21 (1)	Adopted by Ordinance (45-60 days past due)
