AVOID FRAUD




The Federal Trade Commission received more than 2.1 million fraud reports from consumers in 2021, according to newly released data, with imposter frauds remaining the most common type of fraud

reported to the agency. Online shopping, prizes, sweepstakes, lotteries and telephone and mobile services are typical fraud avenues. Consumers reported losing more than \$3.3 billion to fraud in 2021, up from \$1.8 billion in 2020. Nearly \$1.2 billion of losses reported last year were due to imposter frauds, while online. These numbers and statistics have started to sneak into the Town of Bayfield. Last year the Bayfield Marshals Office handled 21 reported calls involving frauds and scams, this year has also started with several unique frauds. Two of our more recent ones have involved using Law Enforcement as the "bait" to get people to wire, send, or somehow transfer monies to help family members or collect property. This is easily done by just linking and gathering information about an agency and then adding it into the fraud. Many people want to believe if a call or such is coming from a law enforcement agency, it is legit, and no agency would ever do this. For the scammers, it is a game of numbers, if they do this 1000 times and get one person to give them what they need which is usually their hard-earned money than they have won. Here is a list of items that should be disposed of in a trash receptacle not in the toilet. These products listed below require mechanical separation prior to the treatment process.

<u>Do Not Flush List:</u> Diapers, facial pads, dental floss, cotton swabs, cigarettes, cotton balls, baby wipes, all purpose cleaning wipes, hair, kitty litter, women hygiene products, gum wrappers, makeup remover wipes and cooking oil or grease.
